1st Maritime Safety International Conference

On July 8-10 2018, the Department of Marine Engineering Department, Faculty of Marine Technology, Institut Teknologi Sepuluh Nopember supported by IEEE held the 1st Maritime Safety International Conference (MASTIC) in Bali. MASTIC 2018 is a conference aim to exchange the latest information, development and innovative ideas in the field of marine

technology, particularly related to the safety of ships operation and the safety of maritime industry. The theme of conference "Cultivating Knowledge, Professionalism. and Networking Toward Global Maritime Safety Environmental Protection". 1st MASTIC

begun with the opening speech by Prof. Joni Hermana as rector of Institut Teknologi Sepuluh Nopember and Prof. Fitri Yuli Zulkifli as Chair of IEEE Indonesia Section, followed by keynote speech by Professor Takeshi Shinoda and Professor Masao Furusho as keynote speakers.

In his speech, Professor Takeshi Shinoda explained, most ship accident that occur in the world,

apart from natural factors, can also occur due to human error factors. Therefore, he stressed that implementing the Formal Safety Assessment (FSA) which was inaugurated by the International Maritime Organization (IMO) in 2002 was very important by maritime actors in any country. In line with Professor Takeshi Shinoda, Professor Masao Furusho alsa explained that safety in

the maritime world was determined from man, machine, media and management. Of these four factors, it is the human factor that occupies the first position. The conference received 136 proposals for publication texts from prospective

speakers, but after a very rigorous evaluation, only 85 publications were considered that could be presented. Conference participants included researchers from 11 countries including Indonesia, Malaysia, Singapore, Japan, Korea, China, Australia, Norway, Taiwan and other countries.



Training on Nutrition and Finance Management for Housewives

In collaboration with IEEE SIGHT Indonesia and Ababi Villages officials, HTRE together with Udayana IEEE SB and Udayana IEEE WIE did training for housewives in Ababi Village, Karangasem Regency on 13th July 2018. Topic of training is family nutrition and how to manage family finance. The modul and training were made in game activity to closely enganged with the housewives, and they easly to understand. The training was conducted in the hall of village office.

Furthermore, the team also did donation of outdoor toy for kindergarten in Ababi Village, Karangasem Regency. The activity was conducted in good collaboration with IEEE SIGHT Indonesia. They had surveyed the kindergarten, interviewed the head of village, and the teachers. The teachers needed more outdoor toys, as the number of toys was not enough compared to the number of children. The activity duration was one month, starting from survey until the toy was installed.



IEEE TCS policy and chapter chair meeting



On July 6, 2018 IEEE Indonesia section held a meeting to discuss about Technical Co-Sponsor (TCS) fee newly regulated by IEEE in Bandung. The meeting was attended by Chair of IEEE Indonesia Section, Prof. Fitri Yuli Zulkifli, Chairs of IEEE Chapters in Indonesia and also lecturers from Institut Teknologi Bandung. This meeting mainly discussed about IEEE at glance and IEEE TCS policy.

IEEE Member and Geographic Activities Board had approved TCS Fee Motion as final policy for handling the TCS fees at the November 2017 IEEE Meeting. There are several things that must be considered for the new policy. First, for all conference applications received 1 Jan 2018 or later, in which an MGA Geographic Unit is a technical co-sponsor, the MGA TCS Fee Policy shall apply. Starting 1 March 2018, IEEE MCE will deploy processes to collect the TCS fees for conferences with applications submitted 1 January 2018 or later. And then for any technically co-sponsored conference in which there is no (0%) IEEE financial interest, the MGA co-sponsor shall arrange (via an approved MoU) for recovery of IEEE operation cost in the form of TCS fees. Effective for conferences for which the creation of the MoU starts after 1 Jan 2018, the fees are \$1,000 per event plus \$15 for each paper that is optionally published in Xplore. As an exception to this general policy, MGA will continue to pay those fees in the external (non-IEEE) financial sponsor has a national society agreement with IEEE or has a sister society agreement with one or more of the IEEE societies. If content will not be submitted for submission to IEEE Xplore, then billing for the \$1,000 per conference fee will occur and no \$15 per paper fee will apply.

With the current TCS policy, IEEE Indonesia offers two different scheme to support a conference, namely scheme A (there are no financial support from IEEE Organization Unit in Indonesia) and scheme B (IEEE Organization Unit in Indonesia gives financial sponsor).

Scheme A: No Financial Support from IEEE Organization Unit in Indonesia

In scheme A, committee of a conference has to contact IEEE Indonesia and then submit Letter of Agreement (LoA) Version A and Memorandum of Understanding (MoU) to IEEE HQ. After that, TCS fee will be processed. The next step is MoU Approval. After MoU is approved, conference committee has to submit conference publication form to receive LoA from IEEE for Indexing IEEE Xplore. When LoA is received, committee can hold a conference. After the conference, committee has to submit conference content and Technical Program Questionaire (TPQ), and wait for IEEE decision for publication. If the conference is published, committee will get invoice from IEEE and then pay 1000 US\$ TCS Fee + 15 US\$ per paper published. If the conference is not published, committee will get invoice from IEEE and then pay 1000 US\$ TCS Fee.

Scheme B: with financial sponsor from IEEE Organization Unit (OU) in Indonesia



In scheme B, committee of a conference has to contact Organization Unit (OU) in Indonesia and discuss about Financial Sponsorship Agreement with OU. After that, conference committee submit LoA Version B to IEEE Indonesia Section and submit MoU. After that there will be process for MoU approval. After MoU is approved, conference committee has to submit conference publication form to receive LoA from IEEE for Indexing IEEE Xplore. When LoA is received, committee can hold a conference. After the conference, committee has to submit conference content and TPQ, and wait for IEEE decision for publication.
